Summary

I am a professional director focused on adding value to organisations through strong governance, and bringing my experience from directing, leading and advising many large and small businesses and other entities. Until taking early retirement in 2017, I was a senior partner in the accounting and management consulting firm of Deloitte, based in the Christchurch office. I was with the firm for 36 years, a partner for 24 years, and have significant experience as a functional and technical leader, in accounting and auditing, risk assurance and advisory services, information technology consulting, and as the Christchurch Office Managing Partner for 5 years. I now serve as a Professional Director and Trustee on a range of Boards, including church, property, health, retail, agri-business, commercial, sporting, technology start-ups, financial services, not-for-profit, and charitable organisations.

In 2011 and 2012 I took leave of absence from Deloitte to serve in the role of the General Manager – Economic Recovery for CERA, the Canterbury Earthquake Recovery Authority. I provided the primary connection between Government and the business community, to help facilitate the city's recovery from the devastating series of earthquakes in 2010-2011. In 2011, I was awarded a Fellowship of the New Zealand Institute of Accountants, and in December 2012 was recognised as the New Zealand Chartered Accountant of the Year. From 2013 to 2017 I led the Risk Advisory Services function for Deloitte in the South Island, which incorporated internal audit, risk consulting, cyber security, project QA and data analytics.

I have a significant focus on giving back to my community, through many of my governance roles. This includes several roles in the health and disability sector, with the church and the wider diocese, and the education sector with the University of Canterbury and the Greater Christchurch Schools Network Trust.

- From 2017 to 2021 appointed by the Minister for Tertiary Education to the Council of the University of Canterbury. Elected Pro Chancellor (Deputy Chairman) of the Council, member of the Finance & Planning committee, and Audit & Risk committee.
- From 2013 to 2016 appointed by the Minister of Health to be the Deputy Chairman of the Canterbury District Health Board. CDHB is responsible for the health system in Canterbury, and has around 9,000 staff and annual revenues of around \$2b. I previously chaired the Quality, Finance, Audit and Risk (QFARC) Committee and currently continue to serve as an external appointee.
- Board member of the Court Theatre, an award-winning live theatre company, and member of the Audit and Risk Committee. Now working to design, plan and fund a new \$36m theatre in the Performing Arts Precinct in the Christchurch CBD.

Completed the earthquake repairs of the St Barnabas church, a heritage listed category 1 historic church building, including bringing it up to current engineering standards, and fund raising of \$1.6 million for the additional strengthening and betterment costs required.
- Inaugural Board member of Paenga Kupenga Limited, a holding company established by Te Ngāi Tūāhūriri Rūnanga to hold and grow the resources of the tribe for the welfare and development of the members of their iwi in the Ōtautahi takiwa (Christchurch area).

- Director of Cookie Time Limited, a family-owned company producing NZ's favourite cookies.
